## Selecthoard Minutes February 19, 2025

The meeting was called to order at 6:40 PM by Ann Marie Visconti, Chair, with Curt Robie and Tamarin Laurel-Paine were in attendance as well.

Mark Doane, Administrative Assistant was also present. Town residents present were: Donald and Karri Trask, Maureen Longobardi, Alfonso Longobardi, Louise Harlow, and Adair Laurel-Cafarella. Zoom was also offered to the Town residents with one person on Zoom.

Under Public input, Maureen Longobardi read a long statement that is attached to this report.

It was recommended to send the letter to Katherine Klein, Town Counsel concerning a letter from Jones Long LaSalle Americas Inc. in regard to a commission for the Post Office.

An update was given on converting the Town Hall phone system to Comcast. Much discussion was had, and it was recommended to contact Comcast, and have them come to the Town Hall to meet with the Selectboard.

The Huntley report on the Skyline Trail Dump Capping has been delivered by Huntley Associates, P.C.

It was reported that Laurie Bartkus from Eric Kinsherf Accounting Firm has completed the Schedule A.

Curt reported that any bids received on repairs for the Senior Center Project will be opened on March 3, 2025 at 2:00 PM.

Tamarin Had no new information to share.

It was reported that there are two potential interviews for the Town Administrator position on this coming Saturday, February 22, 2025.

A discussion was held on whether to do a partial audit of the town accounts, or a full audit. \$7,500.00 has been appropriated for a partial audit. Adelson & Company PC states a full audit would be approx. \$25,000.00. No definitive decision has been made.

A rather lengthy discussion was held, once again, on the articles for the Special Town Meeting scheduled for March 29, 2025. The Selectboard was reminded of the posting requirements for the Warrant. The main article of contention is how to pay the accounting firm for April, May, and June, as well as the completion of Schedule A. Ann Marie read from an email from the accounting firm, that money for payment can come from accounts with money still in them. This request can only happen in the last two months of the fiscal year. Adair Laurel-Cafarella, Finance Committee Chair is against this, as he feels it is "sloppy book keeping", and would rather take the \$14,000.00 from Free Cash. The breakdown of the

\$14,000.00 is as follows: April: \$3,000.00; May \$3,000.00; June: \$3,000.00; Schedule A: \$5,000.00 with a total of \$14,000.00.
It was announced that the next Selectboard meetings are scheduled for: March 5, March 19, April 2, April 16, April 30, and May 14. The All-Boards Meeting is scheduled for March 12, the Special Town Meeting is scheduled for March 29, and the Annual Town Meeting is scheduled for May 3.
There being no further business to come before the Selectboard, it was declared closed at 8:00 PM

- 3) Why was the \$6,000.00 NOT USED AS INTENDED?
- 4) Town JUST paid off the International off in May/2024 ...IT was NOT AT the Highway Garage , nor IN it! (Pix) on 5/4/24 4)Does the phrase ... "OR take any action relative thereto"

- 1) Town got a new-Freightliner M2/ in 2019
- -a new Western Star\* APPARENTLY in 2022
- and now a new Freightliner M2/ 2025
